



**BIDDERS:**

1. Ideal Power Solutions
2. Beacon Energy
3. Nizam Energy (Technically disqualified for not meeting the bidder qualification criteria mentioned at serial # 15)
4. Voltaic Power (Technically disqualified for not meeting the bidder qualification criteria mentioned at serial # 4,5,6,7,8,10,12 & 13)
5. Zaid Enterprises (Technically disqualified provided documents reflect system sizes below 100 kWp. As per the tender requirements, we require evidence of net metering for systems with a minimum capacity of 100 kWp.)

**DISCUSSION:** Sr. Executive Procurement briefed the committee in its 146<sup>th</sup> meeting about the technical evaluation for Design, Supply, Installation, Testing & Commissioning of 102 kWp HBL Roof Mounted Grid Tied Utility Interactive Photo Voltaic Solar Power System at IBA City Campus. Five bidders participated in the bidding process. As per recommendation of Sr. Manager Contracts (Project) and in line with requirement criteria set in the bidding documents (1) M/s Nizam Energy, (2) M/s Voltaic Power and (3) M/s Zaid Enterprises were found technically disqualified.

**DECISION:** Recommended to award "Design, Supply, Installation, Testing & Commissioning of 102 kWp HBL Roof Mounted Grid Tied Utility Interactive Photo Voltaic Solar Power System at IBA City Campus" to M/s Ideal Power Solutions at Rs 14,346,083/- (inclusive of taxes) as found to be the most advantageous bid.
