The Committee evaluated the bidders on a technical basis and gave marks as follows:

Sr#	Bidders Name	Marks obtained
1.	M/s. Mustang Security Services (Pvt.) Ltd.	79%
2.	M/s. Askari Guards (Pvt.) Ltd.	81.5%
3.	The Freedom Security	62.5%
4.	Dragon Security Services	45.5%

As per above, only two (2) bidders qualified technically as meeting the minimum qualifying percentage i.e. 70%.

Decision: The Committee recommends opening of Financial Bids of only 2 bidders who have secured at least 70% marks i.e. M/s. Mustang Security Services (Pvt.) Ltd. and M/s. Askari Guards (Pvt.)
