**DISCUSSION:** The committee in its 29<sup>th</sup> meeting for Construction of 32 Nos Faculty Apartment at IBA Staff Town, Karachi vide tender # Project/02/22-23. Seven bidders participated in the bidding process. Financial proposals of the three qualified bidders were opened. M/s Cemcon Associates quoted bid of Rs. 379,817,914/-, was adjusted to Rs. 379,817,148.74 after minor arithmetical corrections.

DECISION: Recommended to award "Construction of 32 Nos Faculty Apartment at IBA Staff Tow Karachi " to M/s Cemcon Associates at Rs. 379,817,148.74 (inclusive of taxes) as found to be most advantageous bid.
