3. Contractor will depute 1xSkilled Technician & 1xHelper at site on permanent basis from 8am to 4pm (Monday to Friday, however staff will be available on call to cater for the emergency. Material consumed in normal maintenance and repair work will be charged at actual subject to cost approval by IBA. Emergency breakdowns and repairs will also be billed separately subject to cost approval by IBA.)
