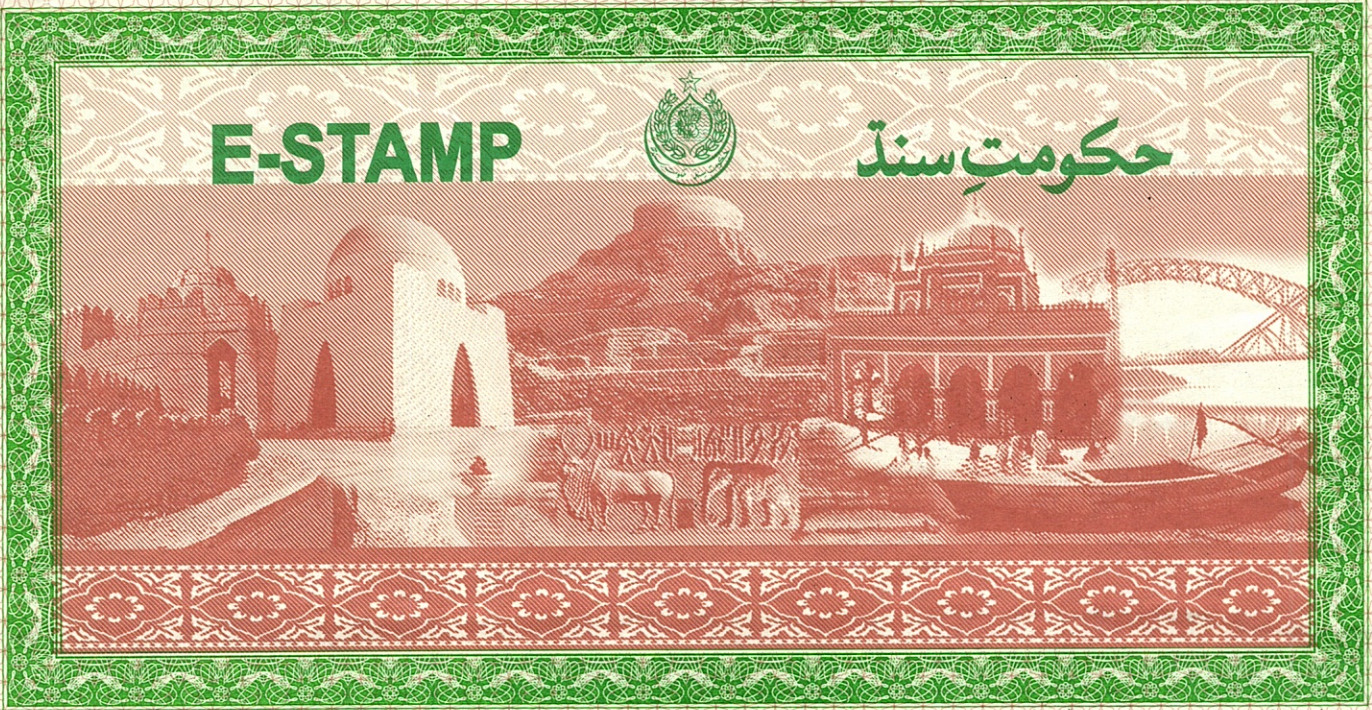

FORM OF CONTRACT AGREEMENT

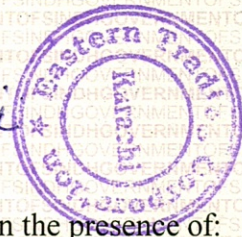
