DISCUSSION: Sr. Executive Purchase briefed the committee in its 79th meeting evaluated the proposal of "Design, Supply, Installation , Testing, & Commissioning of 4 (Four ) Nos Passenger Lifts at Faculty Apartments IBA Staff Town Karachi" vide tender # ME/09/23-24. Three bidders participated in the bidding process. As per recommendation of Sr. Manager Contracts (Project) and in line with requirement criteria set in the bidding documents, M/s Iceberg Industries was found technically disqualified.

**DECISION:** Recommended to award "Design, Supply, Installation, Testing, & Commissioning of 4 (Four) Nos Passenger Lifts at Faculty Apartments IBA Staff Town Karachi" to M/s Kohler Elevators Pakistan (Pvt) Ltd at Rs 35,744,000/- (inclusive of taxes) as found to be the most advantageous bid.
