CONTRACT AGREEMENT

5. The contractor shall be entirely responsible for all the taxes; duties and other such levies imposed by govt. authorities.

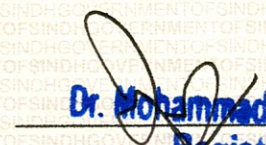

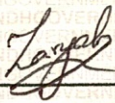

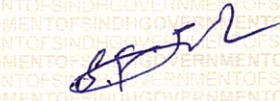
