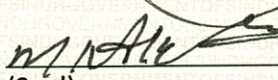

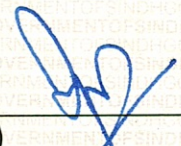
3. 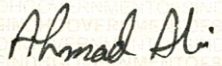

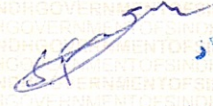
