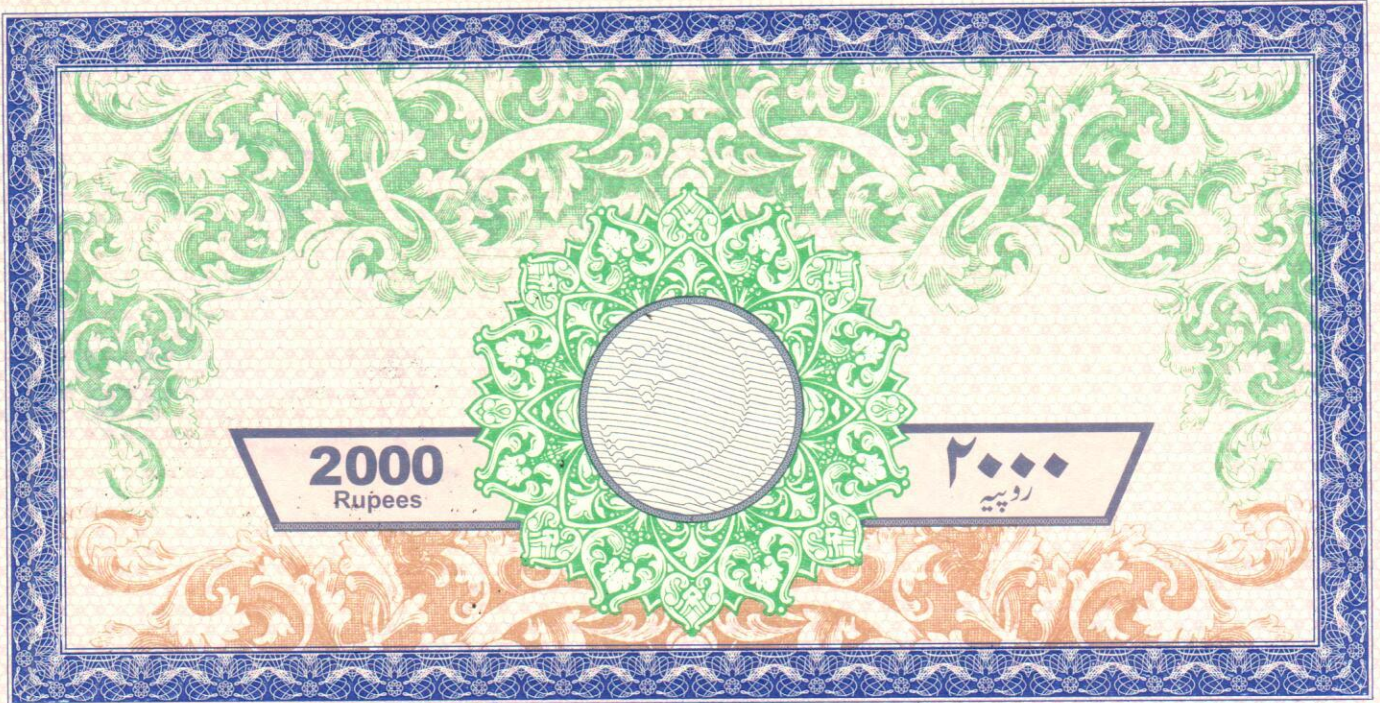

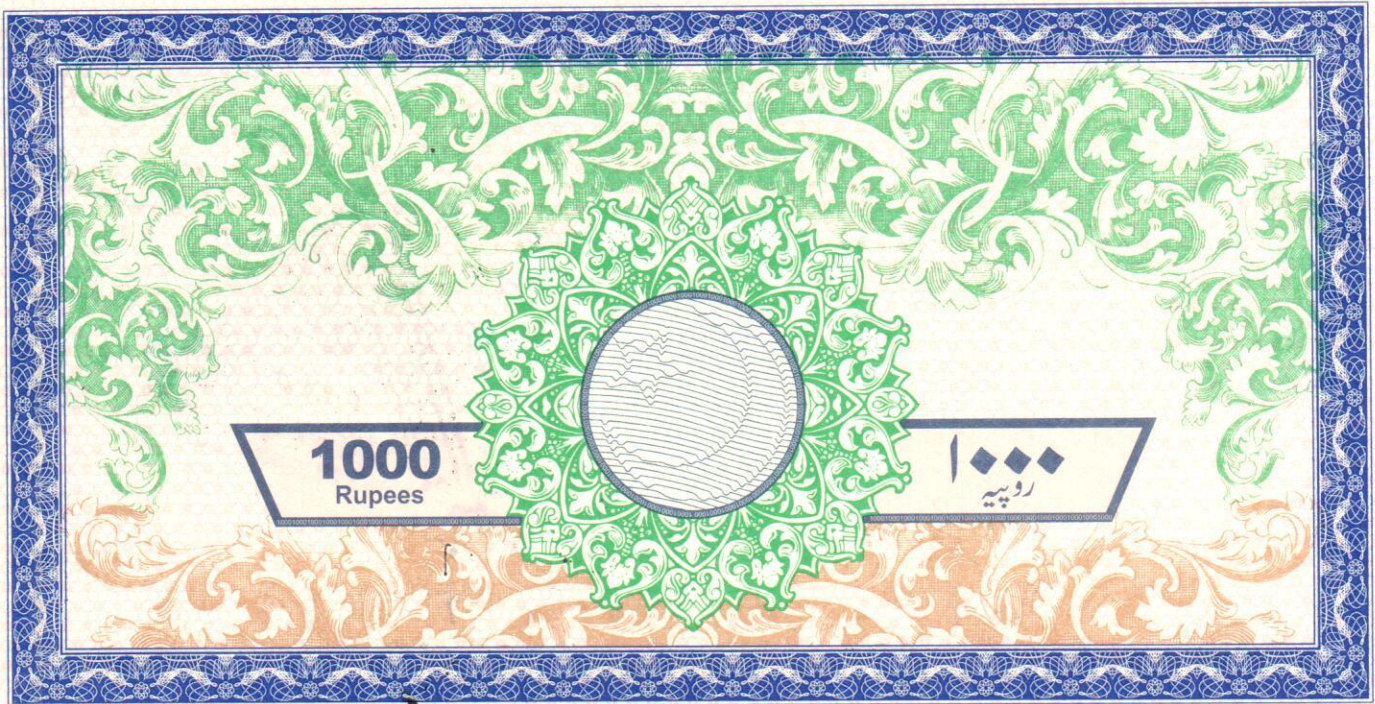

- 9.1 OEM warranty must be provided by the M/s Amisco


Article X:

- 11.5 All terms and conditions of tender vide # ME/03/19-20 will be the integral part of this agreement and can't be revoked.






