

As may surfaces carpeting and rugs must be treated indoors, include all surfaces that may harbor eggs, larvae, pupae or adults such as crevices, in upholstered furniture, floor board, cracks and wall floor joint may all require attention. Outdoors, subfloor areas, lawns and garden particularly if well mulched may all require attention, it is sometimes advisable to wet such areas with a hose prior to insecticide application, as this may help to penetrate, space spraying can be a most useful back-up to treatment of surfaces. The use of an IGR (Insect growth regulator) can disrupt flea development and reproduction. Dustings dusts, though not often used in flea control, can be useful for the treatment of areas where spraying is difficult or dangerous, the treatment of ceiling voids and basement can, if necessary, be carried out using dust formulations. In summary, flea infestation in buildings can present a complex problem, and effective treatment may rely on the co-operation of the occupants.

Steps to take care are:

- 1. Pets to be treatment at the same time of the treatment performed
- 2. Thorough vacuuming and cleaning
- 3. Regular treatment of pets animals in every six month and the importance of cleanliness in home
