- 2.3 A liquidity damages @ two percent (2%) per month up to a maximum of ten percent (10%), of the total agreed price of the Purchase Order, in case of delayed delivery. Liquidity damages will be imposed after the expiry of 8 weeks of issuance of Purchase Order. Purchase will be deemed completed once "THE SUPPLIER" delivers the required number of Lenovo Model P330 Desktop Computer Workstation for BDA Lab to IBA as per specification.
- 2.4 100% payment will be made after satisfactory delivery and submission of commercial invoice and delivery challan by "THE SUPPLIER".
- 2.5 Advance Payment subject to Bank Guarantee.
- 2.6 Delivery on or before March 15, 2019
- 2.7 Performance Security 5% of total amount of Purchase Order will be provided by the M/s DWP Technologies (Pvt) Ltd.

Taxes and Duties

- 2.8 "THE SUPPLIER" shall be responsible for the payment of all taxes, duties etc. incurred or accrued until the final delivery of the Goods or other obligations including services.
- 2.9 Any increase in the rate/amount of Govt. taxes or levy shall be to the cost of "THE SUPPLIER"; however, for any decrease in taxes duties and levy, the IBA should get its benefit
- 2.10 Withholding tax shall be deducted from "THE SUPPLIER" invoices as per the prevailing rates. "THE SUPPLIER" may submit the tax exemption documents if there is any exemption available to them under the FBR Rules

- 2.11 For goods supplied from outside the Pakistan, the Supplier shall be entirely responsible for all taxes, stamp duties, license fees, custom duties and other such levies imposed outside Pakistan.
- 2.12 Stamp Duty @ 0.35% of the cost of purchase order is being paid according to the prescribed procedure.
- 2.13 If any tax exemptions, reductions, allowances or privileges may be available to the Supplier in the Pakistan, the IBA shall use its best efforts to enable the Supplier to benefit from any such tax savings to the maximum allowable extent.
- 2.14 IBA is exempted from custom duties and sales taxes including general sales tax. IBA will furnish the required exemption certificates on demand.
- 2.15 Applicable withholding taxes, rates, duties, etc. shall be deducted from supplier payments.

Article III ARBITRATION

3.1 In case of any dispute, difference or and question which may at any time arise between the parties hereto or any person under them, arising out in respect of this letter of intent or this subject matter thereof shall be referred to the Registrar of the IBA and CEO of the company / firm / agency for arbitration/settling of the dispute, failing which the decision of the court law in the jurisdiction of Karachi binding to the parties. The Arbitration proceedings will be governed by the Arbitration Act, 1940 and the Substantive and procedural law of Pakistan. The venue shall be Karachi.

Article IV TERMINATION

4.1 "IBA" may terminate this agreement if the job is not executed according to the requirement at any time after issuing a 15 days' notice.

Article V INDEMNITY

5.1 "THE SUPPLIER" in its individual capacity shall indemnify and keep IBA and any person claiming through IBA fully indemnified and harmless from and against all damages, cost and expenses caused to or incurred by "THE SUPPLIER", as a result of any defect in the title of IBA or any fault, neglect or omission by the "THE SUPPLIER" which disturbs or damage the reputation, quality or the standard of services provided by "IBA" and any person claiming through the IBA.

Article VI NOTICE

- 6.1 Any notice given under this AGREEMENT shall be sufficient if it is in writing and if sent by courier or registered mail.
- 6.2 If the Agreement or encounters conditions impeding timely performance of any of the obligations, under the contract, at any time, the Contractor shall, by the written notice served on the IBA promptly indicating the facts of the delay, its likely duration and its cause(s). As soon as practicable after receipt of such notice, the IBA shall evaluate the situation and may, at its exclusive discretion, without prejudice to any other remedy it may have, by written order served on the "Supplier", extend the Agreement's time for performance of its obligations under the Agreement
